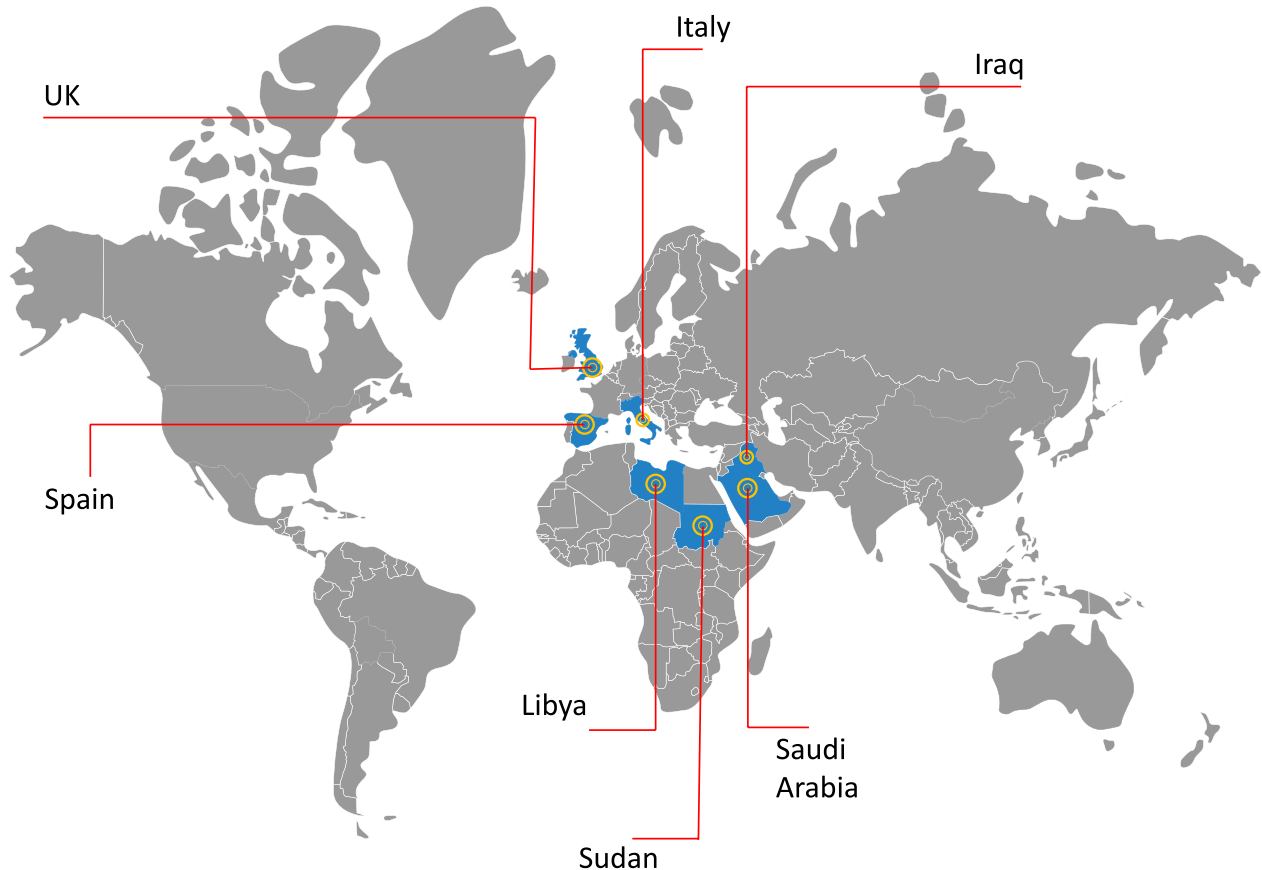
Throughout the course of our 17-year history, our technical expertise and leadership have allowed us to develop a range of innovative products that give the consultant and contractor significant benefits.

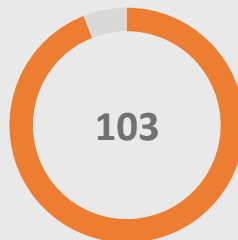

EACH DEPARTMENT**

1- Planning department

The department is responsible for the production and the raw materials planning to achieve the requirements of the sales department to satisfy customer requirements in a way that ensures the highest productivity at the lowest possible costs.

2- Production Department

With the assistance of the technical office team the department is responsible for implementing the production plan provided by the Planning Department while maintaining the resources and equipment and the required quality of the products and reducing the waste percentage to the permissible values in the casting industry.

3- Quality Department (QC & QA)

The department is responsible for measuring and controlling all stages of production completely to ensure obtaining products that conform the customer specifications, EN-124 Standard and ISO 9001 – 2015 Procedure starting from the examination and testing of raw materials received by the company through the in-process control such as the temperature measurements ending with the final product inspection and its reports.

4- Maintenance Department

The department is responsible for the availability of all production and service equipment to work with high efficiency and high capacity in the period from the beginning of the work until the scheduled maintenance date without interruptions.

5- Financial Department

The department is responsible for controlling the cash flow of the company and maintain the working capital to make sure that all the needs of the supply chain department are fulfilled to avoid any interruption of the raw material supply.

6- Supply Chain Department

The department is responsible for purchasing and supplying the needs of the company's departments from the local and foreign market with the required specifications and the best payment methods. The department is also responsible for storing, delivering and receiving materials and products, taking into account the conditions of storage and delivery.

The department is responsible for maintaining the infra structure of the company which include and not limited to website, e-mail, and communication networks.

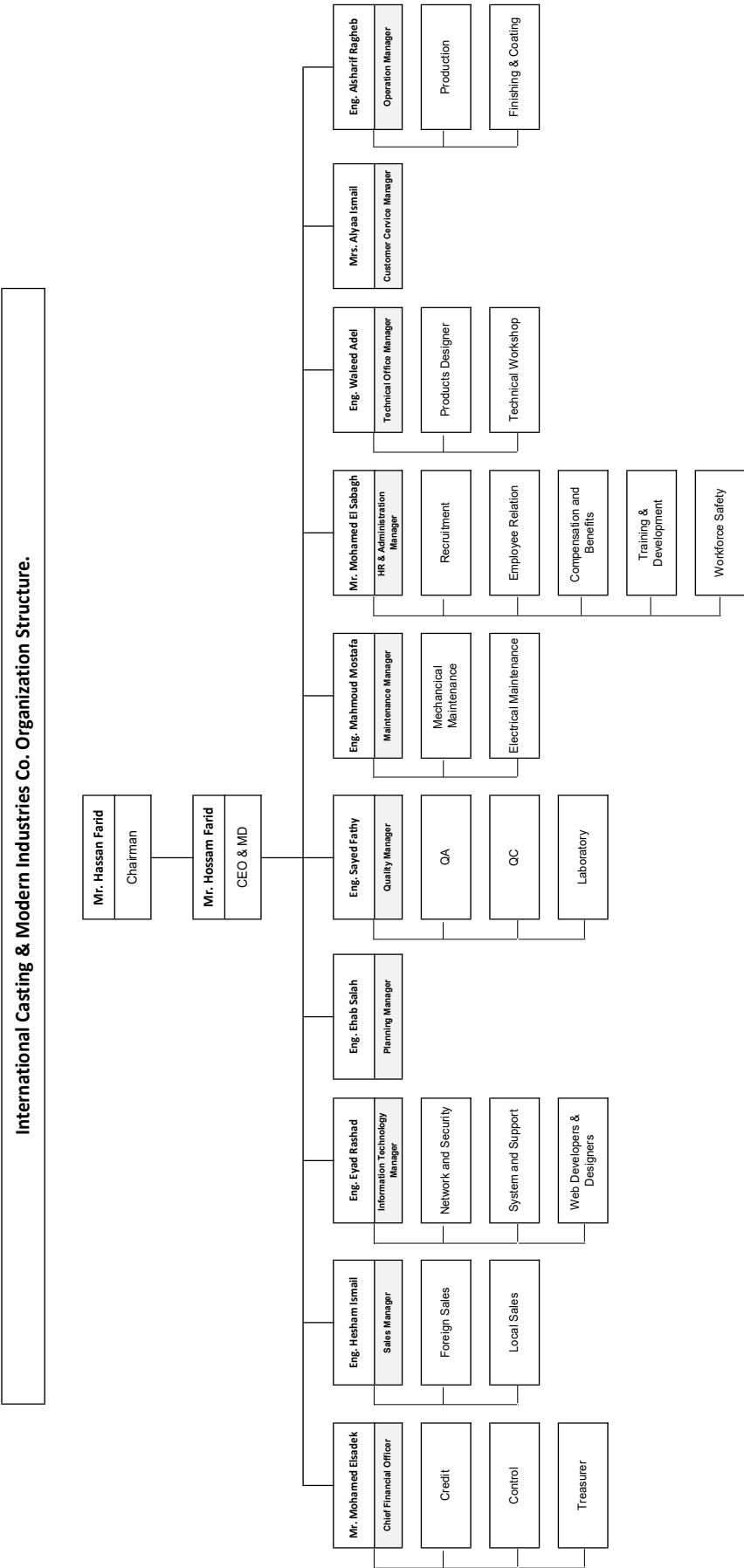
9- HR, HSE & Administration Department
